You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

Options are financial derivative instruments which derive its value from the value of another underlying instrument. This product is a Long (Buy) Over-The-Counter (OTC) Index Option ("**Long OTC Index Option**") entered with CMC on a bilateral basis whereby the investor buys the OTC Index Option by taking a Long Position.

Term

Long OTC Index Options have a fixed term and automatically expire on the Expiry Date.

Objectives

The objective of a Long OTC Index Option is to let an investor take a view on market direction and/or volatility, and on whether the value of an index will move up or down but without an obligation to buy or sell the Index at the Strike Price.

When you enter a Long OTC Index Option position, you pay an option premium (the price of the option). This amount is blocked in your trading account. You do not own the Long OTC Index Option itself. When you close your position prior to the Expiry Date, you will receive or pay the difference between the option premium you paid and the option premium you receive. If the Long OTC Index Option is automatically exercised, you will receive a cash payment.

The option premium can change over time. This depends on several factors, including the difference between the option's strike price and the current index price, interest rates, the time remaining until the option expires, and the expected volatility of the underlying index.

You can enter into two types of Long OTC Index Options, either:

- A **Call Option** gives the buyer the right, but not the obligation, to receive a cash payment if the index price is above the strike price at the Expiry Date. In this case, the **Call Option** is "**in the money**" and will be exercised automatically. The cash payment is calculated as the index value at expiry minus the strike price, minus the option premium. The buyer's maximum potential gross profit is unlimited.

If the index price is **below the strike price**, the **Call Option** is "**out of the money**" and will expire with no value. The buyer's maximum potential gross loss is limited to the option premium paid.

The break-even point is when the index price equals the strike price plus the option premium, meaning there is no profit or loss.

- A **Put Option** gives the buyer the right, but not the obligation, to receive a cash payment if the index price is below the strike price at the set Expiry Date. In this case, the **Put Option** is "**in the money**" and will be exercised automatically. The cash payment is calculated as the strike price minus the index value at expiry, minus the option premium. The buyer's maximum potential gross profit is unlimited.

If the index price is **above the strike price**, the **Put Option** is "**out of the money**" and will expire with no value. The buyer's maximum potential gross loss is limited to the option premium paid.

The break-even point is when the index price equals the strike price minus the option premium, meaning there is no profit or loss.

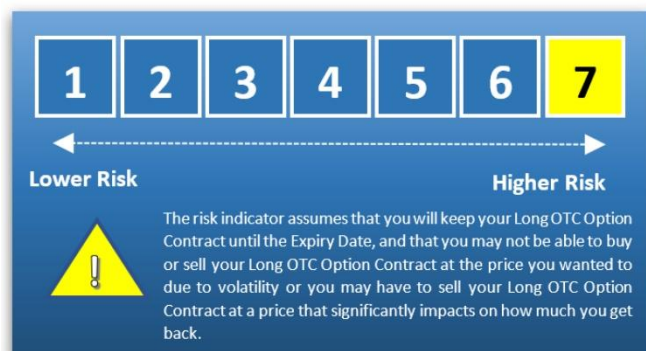
There is no recommended holding period for a Long OTC Index Option, and it is down to the discretion of each individual investor to determine the most appropriate holding period based on their own individual trading strategy and objectives. CMC retains the ability to unilaterally terminate any Long OTC Index Option where it deems that the terms of that Contract have been breached.

Intended Retail Investor

The product is intended for investors who pursue the disproportionate participation in price changes and / or hedging, highest risk tolerance and have a short-term investment horizon. This product is a product for clients with expert knowledge and / or experience with specialised financial products. The investor may bear losses up to the total loss of the capital invested and does not require capital protection.

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class. This rates the potential losses from future performance of the product at a very high level.

Long OTC Index Options are complex instruments. There is no capital protection against market risk, credit risk or liquidity risk.

Be aware of currency risk. It is possible to trade a Long OTC Index Option in a currency which is different to the base currency of your account. The final return you may get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

Performance scenarios

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted. The scenarios shown are illustrations based on results from the past and on certain assumptions. Markets could develop very differently in the future.

The stress scenario shows what you might get back in extreme market circumstances.

Before entering into a Long OTC Index Option (Call or Put), you must make your own independent assessment and decide whether the product is suitable for you. The scenarios shown in the graphs are examples only and illustrate a range of possible returns at maturity.

What happens if CMC Markets Germany is unable to pay out?

If CMC is unable to meet its financial obligations to you, you may lose the value of your investment. However, CMC segregates all retail client funds from its own money in accordance with the requirements of Section 84 of the German Securities Trading Act (WpHG) regarding client funds. How long should I hold it and can I take money out early?

Long OTC Index Options are intended for short term trading.

There is no recommended holding period, no cancellation period and therefore no cancellation fees. You can open and close a Long OTC Index Option at any time during market hours prior to the Expiry Date/ Time at which point your Long OTC Index Option will automatically close.
