Introduction

1. These Referred Client Bonus Offer Terms and Conditions ("**Bonus T&Cs**") form the basis of the opportunity to participate in the bonus offer ("**Offer**"), which is provided by CMC Markets Canada Inc. ("**CMC Markets**", "**us**", "**we**", or "**our**").
2. Taking part in this Offer constitutes your acceptance of these Bonus T&Cs.
3. Effective from 23 March 2026 ("**Effective Date**"), these Bonus T&Cs hereby amend and replace all previous Refer a Friend Terms and Conditions, Sales Trader Refer a Friend Terms and Conditions and offers provided by CMC Markets prior to the Effective Date.
4. Unless defined in these Bonus T&Cs, capitalized terms used, but not defined herein, have the meaning given to them in the *Terms of Business* or the *MT4 Terms of Business* (as applicable), as amended from time to time and available on the CMC Markets Website ("**TOBs**").

Conditions of Eligibility

5. Unless determined otherwise by CMC Markets in its sole and absolute discretion, the Offer is only available to existing customers and new customers who satisfy the Eligibility Criteria set out in clauses 6 and 7 below.
6. An existing customer making a referral must meet the following criteria to be considered an "**Eligible Existing Customer**" to an Offer:
 - (a) the existing customer must have a live and active Account on the CMC Markets Platform or the MT4 Platform;
 - (b) the existing customer must be a resident of Canada;
 - (c) the existing customer must be invited to participate in the Offer by email from CMC Markets and must have received a unique promotional code directly from CMC Markets ("**Email**"); and
 - (d) the existing customer must not be an immediate family member of an employee of CMC Markets or any other company within its group as determined by CMC Markets in its absolute discretion, (together, the "**Eligible Existing Customer Criteria**").
7. A new customer being referred by an Eligible Existing Customer must meet the following criteria to be considered an "**Eligible New Customer**" to an Offer:
 - (a) the new customer must be a person who does not have any existing, pre-existing and/or dormant Account(s) on either the CMC Markets Platform or the MT4 Platform;
 - (b) an Eligible Existing Customer must have referred the new customer to CMC Markets by:
 - i. providing the new customer's details to CMC Markets in writing; or
 - ii. sharing the unique referral link received via the Email with the new customer;
 - (c) the new customer must be a resident of Canada; and
 - (d) the new customer must not be an immediate family member of an employee of CMC Markets or any other company within its group as determined by CMC Markets in its absolute discretion, (together, the "**Eligible New Customer Criteria**").
8. The Eligible Existing Customer Criteria and the Eligible New Customer Criteria are collectively referred to as the "**Eligibility Criteria**".

Offer Period

9. The Offer begins on the Effective Date and will remain open until such time as determined by CMC Markets in its sole and absolute discretion ("**Offer Period**").
10. CMC Markets reserves the right to withdraw and/or modify this Offer at any time and without prior notice, by

updating these Bonus T&Cs on the CMC Markets Website.

The Offer

11. The Offer entitles an Eligible Existing Customer and the referred Eligible New Customer (each an “**Eligible Customer**”) to receive from CMC Markets a one-time bonus amount, if the following conditions are satisfied before the Offer Period ends (the “**Bonus Conditions**”):
- (a) the Eligible New Customer must open an Account on the CMC Markets Platform or the MT4 Platform;
 - (b) the Eligible New Customer must deposit at least one thousand Canadian dollars (CAD 1000) into their newly opened Account within thirty (30) days from the date the Eligible New Customer’s Account is opened (the “**Minimum Deposit**”); and
 - (c) during the period of sixty (60) calendar days beginning on the date the Eligible New Customer’s Account is opened (the “**Minimum Period**”):
 - i. the Eligible New Customer must keep the Minimum Deposit in their Account; and
 - ii. the Eligible New Customer must make a minimum of ten (10) trades.
12. Subject to the terms of these Bonus T&Cs, if an Eligible New Customer satisfies all of the Bonus Conditions, the Eligible New Customer and the Eligible Existing Customer who referred it, will each receive a Bonus in the amount specified as the Cash Bonus in the table below for the Tier corresponding to the Minimum Turnover met by the Eligible New Customer (a “**Bonus**”).

Tier (the “Tier”)	Trading turnover threshold (CAD)* or number of trades (the “Minimum Turnover”)	Cash bonus (CAD)* per Eligible Customer (the “Cash Bonus”)
1	10 trades	\$150
2	CAD 10 million trading turnover	\$500
3	CAD 50 million trading turnover	\$2,500

*If the Account Currency applicable to your Account is in USD, then CMC Markets will use the CMC Currency Conversion Rate to convert any CAD amounts in this table into USD amounts for the purpose of determining whether you meet the requirements of this Offer.

13. If an Eligible New Customer does not reach the Minimum Turnover threshold within the Minimum Period, neither the Eligible New Customer nor the Eligible Existing Customer shall be entitled to receive the corresponding Bonus.

Bonus Payment

14. CMC Markets will credit the Bonus into each Eligible Customer’s Account within a reasonable timeframe from the lapse of the Minimum Period. Eligible Customers can contact our client management team at any time for confirmation of whether the relevant Eligible New Customer has met the applicable Minimum Turnover, as this information is not available on the Platform.
15. Any trades that are subsequently voided, reversed, or cancelled by the Eligible New Customer or CMC Markets will not be taken into consideration for the purposes of meeting the Bonus Conditions. If CMC Markets has already paid out the Bonus in respect of any trades that are subsequently voided, reversed or cancelled, CMC Markets reserves its right to claim back from any Eligible Customer the Bonus paid in respect of such trades to the extent that the Minimum Turnover would no longer be met.
16. The Bonus payment does not represent and shall not be interpreted as a commitment from CMC Markets

to make any further payments in the future.

17. The Bonus is subject to, and contingent upon, each Eligible Customer's compliance with these Bonus T&Cs and the TOBs applicable to its Account. In addition to any other rights and remedies we may have, any breach or suspected breach of these Bonus T&Cs and/or the TOBs applicable to an Eligible Customer's Account will entitle us to deduct the Bonus immediately from that Eligible Customer's Account and without prior written notice, and/or reclaim payments previously paid pursuant to these Bonus T&Cs.
18. CMC Markets reserves the right to withhold, cancel, and/or refuse to pay any Bonus where, in CMC Markets' view, trades are or were made to manipulate the Offer or where an Eligible Customer may have breached or, in CMC Markets' view, potentially breached, these Bonus T&Cs, the TOBs applicable to the concerned Accounts or any law, regulation, or licensing requirement.
19. Each Eligible Customer who successfully takes part in this Offer is responsible for any and all taxes payable (if any) as a result of the Bonus payment being awarded, received or accepted.

Legal

20. The Bonus shall not be awarded more than once per referral if multiple Accounts are opened by the same Eligible Customer as part of the same referral. For the avoidance of doubt, where an Eligible New Customer opens more than one Account, neither the Eligible New Customer nor the Eligible Existing Customer who referred that Eligible New Customer will be entitled to receive more than one Bonus in respect of that referral.
21. This Offer must only be used for personal and non-commercial purposes. The unique link contained in the Email should not in any event be published or distributed publicly without CMC Markets' prior written authorization.
22. All persons taking part in the Offer, to the maximum extent permitted by law, release from, and indemnify CMC Markets against all liability, claims, costs, losses, damages or expenses, whether direct or indirect, that arise in contract, tort or otherwise, out of or in connection with the Offer.
23. Notwithstanding any other term in these Bonus T&Cs, CMC Markets may at any time and in its absolute discretion decide to cancel any Bonus credited to an Eligible Customer's Account, including where CMC Markets considers that it would be inappropriate or where CMC Markets has exercised its right to close an Account in accordance with the applicable TOBs.
24. The Offer should not form the basis of any decisions made in relation to potential trades or Account activity. Furthermore, a Bonus payment is not intended to limit an Eligible Customer's liability in respect of trades and may not be used to set-off any payment obligations towards us.
25. This Offer cannot be combined or used in conjunction with any other offer, rebate, or promotion, or with additional payments offered by CMC Markets.
26. Failure to meet any of the requirements outlined in these Bonus T&Cs will result in an Eligible Customer's automatic disqualification from this Offer.
27. Any failure by CMC Markets to enforce any of these Bonus T&Cs in any instance(s) will not give rise to any claim by any person or prevent CMC Markets from taking enforcement action later.
28. Except where an Eligible Customer is a resident of the Province of Quebec:
 - (a) these Bonus T&Cs and any contractual or non-contractual obligations arising thereof are governed by, and interpreted in accordance with, the laws of the Province of Ontario and any applicable federal laws;
 - (b) each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of the Province of Ontario and all courts competent to hear appeals therefrom; and
 - (c) all judicial or administrative actions or proceedings arising directly or indirectly hereunder, whether brought by an Eligible Customer or CMC Markets, shall be held within the judicial region of Toronto, Ontario.

 - (b) each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of the Province of Quebec and all courts competent to hear appeals therefrom; and
 - (c) all judicial or administrative actions or proceedings arising directly or indirectly hereunder, whether brought by an Eligible Customer or CMC Markets, shall be held within the judicial district of Montreal, Province of Quebec.
