Who Is MCIC?

The Maryland Community Investment Corporation (MCIC) is a new entity created by Governor Moore's administration to bring equitable, community-driven investment to Maryland. We work to connect grassroots organizations, developers, and anchor institutions to funding opportunities and technical assistance—especially through tools like the New Markets Tax Credit (NMTC) program.

MCIC is here to **bridge the gap** for organizations that have historically been left out of complex funding programs, with a focus on:

- Community-serving real estate projects
- Underserved and rural areas
- Mission-driven organizations and minority-led developers

WHEN TALKING TO GRASSROOTS ORGANIZATIONS:

"This is a short survey that helps MCIC understand what kinds of real estate or infrastructure projects are happening in Maryland's underserved communities. If you're planning a project—or even just have an idea—filling out this survey is the first step toward support and potential funding."

WHEN TALKING TO INVESTMENT-READY DEVELOPERS:

"MCIC is building a funding pipeline for projects in NMTC-eligible areas. This survey helps identify leaders already doing the work. By filling it out, your project can be prioritized for technical assistance, future funding, and other partnership opportunities."

What Is This Campaign?

MCIC, together with the Neighborhood Design Center and Community Development Network, is launching a **statewide Community Needs Assessment Survey.**

The goal? To identify:

- Who is working on community-serving projects in NMTC-eligible areas
- What support and funding they need
- How we can help build a pipeline of investment-ready projects

The survey is **open to nonprofits, community developers, and grassroots organizations**—especially those working in under-resourced communities.

By collecting this data, MCIC can:

- Design technical assistance programs
- Inform funding priorities
- Ensure that future investments reflect real needs from the ground up

WHO SHOULD FILL OUT THE SURVEY?

Any organization or developer working on—or exploring—a community-serving real estate project, especially in NMTC-eligible areas.

WHAT KIND OF PROJECTS QUALIFY?

Health centers, arts/cultural spaces, rec centers, childcare facilities, mixed-use buildings, grocery stores in food deserts, small business hubs, and more.

IS FUNDING AVAILABLE RIGHT NOW?

This survey is the first step. It helps MCIC understand the pipeline and build a support system—including future funding opportunities.
