## **EDITORIAL**

#### In Praise of Celebrations

Dear Ph.D. students,

When pondering over important ingredients in one's journey towards the Ph.D., I was struck by the quasi-absence of celebrations from that list. Hard work, conceptual clarity, expertise in a well-defined domain, flawless methods, networking within the profession, all figure prominently. Less so treating yourself to a scrumptious dinner, spending a day in a park or a museum, a party with friends, or a night of dancing. While we do know of the positive effects of praise, we are less prone to recognize the role of one's own celebrations of – however small – victories along the arduous road toward the Ph.D.

Celebrations of what, you may ask; very few students have publications, which is academics' typical notable accomplishment. You may even sometimes feel like little Tom Thumb - the youngest, weakest family member by all appearances - as your former university or work colleagues get promoted, buy houses, start families. While you are still to start considering any of these. Yes, mother, I am still a student I hear you say on skype, trying to sound confident and reassuring.

Of whatever deserves to be celebrated, I answer. A promising exchange with a faculty member, and her decision to take you on as a mentee. A term paper that gets the comment 'Excellent idea, develop further'. An acceptance to a conference. The addition of a renowned expert to your committee.

Such celebrations are key to fueling the energy needed to push through a hard project, teach yourself a new software package, get up the courage to call on your contacts who may give you access to a field study, rewrite your paper using a new theoretical framing. Of course, an advisor's encouragement and friends' support are also important in boosting your motivation. Still, celebrations give us pause and perspective, and help us go on with our struggles.

I think of these self-generated celebrations as the crumbs left behind by little resourceful Tom Thumb, who knew the way to safety had to be peppered with tiny markers of the road accomplished. Like Tom, you know there is a road that leads to a desired place, albeit a road you build yourself, pebble by pebble. Like Tom, you can find your way by staying alert, by taking initiatives, and by spreading little pebbles on your road.

Of course there's a limit to this analogy. While Tom's pebbles helped him find his way back to his well-known home, yours are meant to help you find your way to the desired, as yet only vaguely perceived destination. The rewards and celebrations you give yourselves are meant to show you that there is a way, and that you're building it yourselves, little victory by little victory. The large victory will thus become all the more yours.

So go ahead, have a picnic, go rowing, buy yourself a bunch of flowers, make a dinner for your friends, dance the night away – every time you feel you deserve it; every time you feel a friend deserves it.
