With a strong emphasis on developing both academic and practical skills, the Bachelor cycle prepares students for advanced study and professional careers across multiple industries. At the end of the 1<sup>st</sup> Cycle, students receive a Bachelor Double Degree from ESSEC Business School and CY Cergy Paris Université.

Throughout the five-year program, students will gain valuable professional experience totaling 11 to 14 months. This hands-on training is divided across the program: one month in the first year, two months in the second and third years, two to three months during the first year of the Master's cycle (M1), and a more substantial four to six-month internship in the final year (M2). This progressive immersion into the professional world helps students apply theoretical knowledge, develop practical skills, and build a strong network in their chosen field.

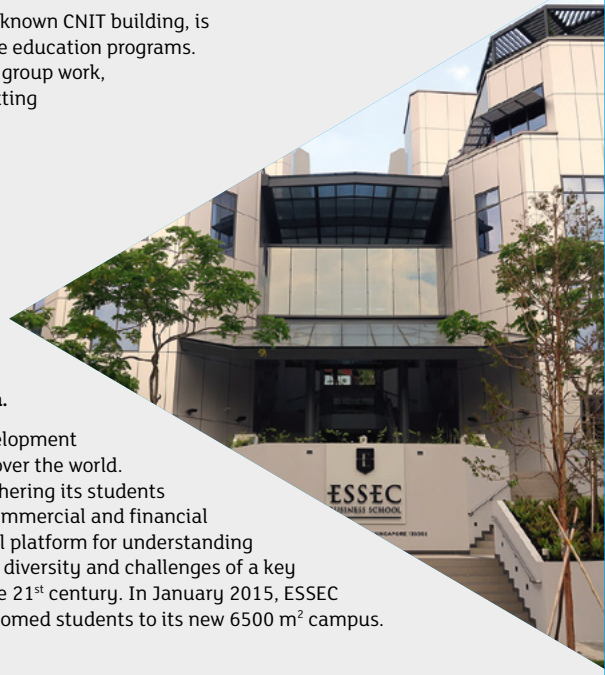


## THE PARIS-LA-DÉFENSE CAMPUS
