Rainfastness	Do not apply if rainfall is forecast within 2 hrs of the time of application
Water Volume	Minimum 5 US gal/Acre
For Best Results	Try to spray when weeds are actively growing. Dry or hot conditions can result in reduced weed control. Try to add a non ionic surfactant when spraying under hot/dry conditions

MIXING PROCEDURE

- 1. Fill spray tank 3/4 full of water.
- 2. Start agitation and run for entire mixing and spraying operation.
- 3. Add required amount of the tank mix partner
- 4. Flush herbicide loading tank and herbicide containers with water.
- 5. If using a herbicide loading system ensure that the loading tank and lines to the pump are empty and flushed out with water before adding tank mix partner.
- 6. Add required amount of Smoke® 540.
- 7. Flush herbicide loading tank and herbicide containers with water.
