# **MIXING PROCEDURE**

1.Make sure that the spray tank is thoroughly cleaned before mixing.

2. Fill the tank half full with water. KEEP AGITATOR RUNNING.

3. If tank mixing ELEGANT 10 EC with another herbicide, use the following sequence:

- MUSTER® Herbicide or PINNACLE® Toss-N-Go® Herbicide, CLASSIC® Herbicide or RELIANCE STS Toss-N-Go® Herbicide
- BASAGRAN® FORTE Herbicide
- ELEGANT 10 EC
- Slowly add MERGE® or SURE-MIX<sup>™</sup>
- Ensure that the herbicide is completely mixed before proceeding to the final step

4. Add the rest of the required water to the tank. Mix well before applying to the crop.
