## **What does Sizzle™ do?**

- Sequesters metal cations in hard water
- Reduces spray tank pH
- Activates glyphosate
- Enhances wetting and penetration
- Satisfies crop oil requirements for select herbicides
- Oil-base doubles as a drift and deposition aid that works with all nozzle types
- Effective at half the rate of competitive products

## **How do I use Sizzle™ for best results?**

- Apply 1-2 qt/100 Gal (0.25%-0.50% v/v) in glyphosate-only tank-mixes
- Apply 2-2.5 qt/100 Gal (0.5%-0.625% v/v) for tank-mixes with an oil requirement
- Sizzle has broad list of benefits in tank-mixes where glyphosate is used and/or a crop oil is required:
  - Glyphosate and clethodim tank-mixes
  - Fall burndown applications containing flumioxazin or atrazine where an oil is required
  - Volunteer wheat control in the fall to help stop the “green bridge”
  - Fall or spring paraquat tank-mixes that require an oil
  - Cover crop termination
