

# **Publication Scheme and Guide to Information Policy**

### **Purpose**

The Freedom of Information Act 2000 requires every public authority to adopt and maintain a publication scheme setting out the classes of information it holds, the manner in which it intends to publish the information, and whether a charge will be made for the information.

#### Scope

Our Publication Scheme is designed to give everyone routine access to information relating to the Restoration and Renewal Programme. Our Guide to Information, which follows below, sets out the classes or types of information we are committed to publishing and when we will publish it. The Programme does not routinely charge for information.

## **Principles**

The Programme's policy is to publish as much information as possible. We may not be able to publish some information or data that is protected by law. This includes sensitive information, such as legal advice, commercial or security matters.

Most of the information in our Publication Scheme is available from our website, where it is available to view free of charge. If an alternative format is required, we will do all we reasonably can to help.

The information listed in our Publication Scheme is available for re-use under the terms of the Open Government Licence unless otherwise specified. This applies to the re-use of our information, but you may still need permission to re-use information which originated with third parties.

#### Review

This policy will be reviewed annually, over the life of the programme, or sooner if there is a specific legislative, regulatory, or service requirement or a change in practice to support the improvement of this policy.
