

OFFICIAL RULES – Nationwide® Pet Crew Sweepstakes

ELIGIBILITY

To enter complete one of the following options:

1. Visit <http://www.petinsurance.com/PetCrew> during the Sweepstakes period and send our Car Safety E-Card to a friend. You must provide your name, your email address, your friend's name, your friend's email address and select your state of residency to be eligible to enter.

2. Visit <http://www.petinsurance.com/PetCrew> during the Sweepstakes period and click the “share on Facebook” button below the Car Safety E-Card. Fill out the form by entering your e-mail address and state of residence. Share the e-card on your Facebook wall by clicking the Share button.
