

# 1989


We play a leading role in the global response to the AIDS pandemic, appointed as lead agency for HIV on behalf of the Caritas Catholic network.



# 1960

Jacqui Stuyt and women from the National Board of Catholic Women organise the first Family Fast Day to raise funds for a mother and baby clinic in Dominica. The Bishop's Conference registers CAFOD as an official charity two years later.





1977

CAFOD is working in over 40 countries including El Salvador, supporting Archbishop Oscar Romero in his fight for justice.

# 1992

We co-found the Fairtrade Foundation and are at the forefront of campaigns for debt relief, overseas aid and climate justice.



# 2004

An unprecedented outpouring of support from the Catholic community enables us to upscale our response to the Boxing Day Tsunami and increase our support in many more countries.

When thinking about my Will, I of course think about my own children and my grandchildren. But there are


also millions of other children in the world, not so lucky, living in conditions of deprivation. Families with severely limited resources pushed to the absolute limit.



# **Preparing to make your Will**

What do I want to happen to the things I've built up over a lifetime?

How do I want to provide for the people and causes I care about?

How can I leave my mark?

Making a Will raises practical and personal questions. Taking the opportunity to reflect and prepare will save you time and money and avoid complications in the future.

#### The people you love

We know that loved ones come first. Whether this is family or friends, think about who you want to remember and what type of gift you would like them to have. If you have dependants, consider who will look after them.

#### The causes close to your heart

Gifts in Wills are a lifeline to charities. For CAFOD, they pay for a third of our international development projects. Thanks to a gift in your Will, your lifetime's support will continue, saving and changing lives for the years to come.

### Who you trust to carry out your wishes

An executor makes sure your wishes are carried out. Most people choose two. They can be a professional, like a solicitor or bank, or a relative or friend. They can be beneficiaries in the Will (unlike witnesses, who cannot).

### How to write your Will

We recommend your Will is written with the help of a professional. Otherwise, it can be easy to overlook something that might cause complications down the line. Find out more about our Will-writing options on the next page.

## **How to write your Will**

A Will has to be written properly to be valid, but it doesn't have to be a complicated process. Using a professional service will help you make sure nothing is overlooked.

# Different types of gift

Just like leaving something for family or friends, it's easy to include a gift to CAFOD in your Will. There are three main types of gift to choose from:

### Leaving a share of your estate

You can leave a percentage of what's left of your estate after all other payments and gifts have been paid. This type of gift is popular because you don't need to worry if your financial situation changes, for example after care costs. It will adjust automatically, and it doesn't lose value with inflation.

### Leaving a cash gift

You can leave a cash amount in your Will. You might want to index-link your gift so it reflects your intended value and the impact you want the gift to make in the future.

### Leaving a specific item

You can leave a specific item which can be used or sold, such as property or shares.

### **Inheritance Tax**

Some estates are subject to Inheritance Tax. Inheritance Tax can be complicated so it's important to discuss the implications with a professional. Here are the basics:

- Inheritance Tax is payable on estates over £325,000. This amount is the IHT threshold, also known as the nil-rate band.
- Inheritance Tax is currently charged at 40%. For example: Estate = £400,000. Subtract the £325,000 threshold and IHT is charged on the remaining £75,000. IHT bill = £30,000 (40% of £75,000).
- Inheritance Tax is not payable on assets passing from one spouse or civil partner to another.
- If the main home, or sale proceeds of that home, is left to children or grandchildren, the IHT threshold increases by a further £175,000. This is known as the residence nil-rate band.
- If Inheritance Tax was not payable upon the death of the first spouse or civil partner (for example, if they left everything to their surviving partner or their estate was worth less than the IHT threshold) the first partner's tax-free allowance is transferred to the second partner. This means a surviving partner's IHT allowance can be up to £1 million (two nil-rate bands and two residence nil-rate bands).

# Reducing your Inheritance Tax by giving to charity

With advice and planning, you can reduce the amount of your Inheritance Tax. Here are the basics:

- Gifts to UK-registered charities are free from Inheritance Tax.
- The Inheritance Tax rate is reduced from 40% to 36% if 10% or more of the net estate over the IHT threshold is left to charity.
- In some situations, increasing a charitable gift to 10% can actually mean your loved ones receive more money.

The table below shows how a gift of 10% to CAFOD would leave the same amount for the family as a gift of 4% and even more than a gift of 6%, because of the reduced Inheritance Tax rate:

Estate	Chargeable for IHT after NRB	% to charity	£ to charity	Taxable	IHT rate	IHT bill	£ to family
£600,000	£275,000	4%	£11,000	£264,000	40%	£105,600	£483,400
£600,000	£275,000	6%	£16,500	£258,500	40%	£103,400	£480,100
£600,000	£275,000	10%	£27,500	£247,500	36%	£89,100	£483,400

A gift of 10% to charity can reduce your Inheritance Tax.



## Remembering loved ones

Writing a Will is a chance to say how you wish to be remembered. As well as describing the type of service and memorial you'd like, you can decide how these should be paid for. You can also state if you'd like flowers at your funeral or would prefer donations to be made to a favourite cause.

Charitable gifts in memory of a loved one can offer family and friends an opportunity to do something positive at a difficult time. It can help them to know that the memory and values of their loved one will live on in the good work supported by their gifts.

If you would like to be remembered in this way, let your family or executors know. They will be able to put a notice in the paper or inform others of your chosen charity when the time comes.

When writing your Will, you can also choose to leave your legacy gift in memory of a loved one.



# **Checklist and next steps**

We hope this guide has taken you through the essentials you need to consider, and you're now closer to being ready to make your Will.

Her	e is a checklist for your next steps so you can keep the ball rolling:
	Decide who you would like to remember in your Will and what you would like them to have.
	Decide what type of gift you would like to leave to CAFOD and any other charities. See page 16 for the different types of gift you can leave.
	Choose the people who will play an important role – your executors and guardians for dependants. You can even choose who will look after any pets.
	Speak to your loved ones about your wishes, and make sure your appointed executors and guardians are happy to take on the responsibility.
	Make your appointment with your Will-writer. See page 13 for CAFOD's free Will options.
	Once your Will is written, keep it in a safe place. Remember that you may need to update your Will as your circumstances change.
