Parishes hold debt petition signings!

We've been delighted to hear of parishes getting the **worldwide petition about the debt crisis** signed through May and June. Please can you plan to get the petition signed in your parish if you haven't already? We're working with our sister organisations in the Caritas network to get it signed in parishes all over the world and we need as many signatures as possible!

We have a poster with a **letter from Father Charlie Chilufya**, a priest based in Kenya, explaining the impact of debt on ordinary Kenyans, and **petition sheets** for people to sign on their way in or out of Mass. Please note that the petition sheets shouldn't be left unattended once people have signed them, for data protection reasons. 'Act Now, Change Forever' Mass lobby of Parliament: Wednesday 9 July

Over 100 organisations are coming together as part of The Climate Coalition to organise a mass lobby of Parliament on Wednesday 9 July in London. 2000 people have registered at the time of writing and it's going to get much bigger! Register at <u>cafod.org.uk/masslobby</u>

In this Jubilee Year, with a global debt crisis affecting the world's poorest countries, this event is a unique opportunity to speak to our MPs about debt cancellation for countries also hit hardest by the climate crisis.

MP meetings will run from 9.30am to 7pm, with a communal moment over lunchtime. **In order to meet your MP, you must register for a place**, and then you will be told the time of your meeting.



Organisations will also have a hub for the day at the QEII Centre in Westminster for people to drop in throughout the day, with speakers and stalls. We would also like to invite you to join us at the daily 5.30pm Mass at Westminster Cathedral.

This is a chance to take the message of the debt petition directly to our politicians. We would be thrilled to see you there. Register at cafod.org.uk/masslobby

Who is the petition addressed to and when does it end?

It's addressed to 'world leaders' so that we can use it at various points during the year, in the UK or globally as part of Caritas. It will run for the whole of 2025. It will be used in communications at key political moments such as the G7 in Canada this month, the Financing for Development Conference in Seville at the end of the month and the COP30 climate conference in Brazil in November.

Do people have to give their address and email address?

They have to give their address as it's an official petition, but the email address is optional. Obviously, we'd love people to sign up to get email updates from us, but their signature will count without their email address.

Welcome Pope Leo XIV

Since our last update the world has mourned the passing of Pope Francis and has welcomed Pope Leo XIV. An interfaith group of campaigners prayed and lit candles outside the UK Treasury at the end of May. At the same time, candles were being lit, many outside financial institutions, in 40 countries as part of the Caritas Relay of Hope, to call for action on the global debt crisis.
