appoint one executor it is a good idea to include a substitute executor in the event that the first is unable to act. Your executors can be family, friends or a professional. They can also be beneficiaries under the Will (unlike

witnesses). Check your executors are willing to accept the responsibility.

Witnesses <u>must not</u> be beneficiaries in your Will. You and both witnesses must sign your Will together without leaving the room, or via video following specific guidelines.

### **Your estate**

Note down your major assets and their estimated value, along with any significant debts. This will give you an idea of the value of your estate. It will also help you assess any Inheritance Tax implications so you can seek advice accordingly. (See our guide for more information about Inheritance Tax).

# **Remembering a charity**

When naming a charity, it's important to include its full registered details to ensure your gift reaches them even if they move offices or change their name over the years. You or your adviser will be able to find this information on the Charity Commission website, which has details of all UK registered charities (charity-commission.gov.uk).

### **Suggested wording for your Will**

If you have decided to remember CAFOD in your Will, we'd like to take this opportunity to say a huge thank you. Your gift will truly make a difference to vulnerable communities.

Here is an example of how the gift can be worded in your Will:

#### A share of your estate:

I give [all/fraction/% share] of the residue of my estate to the Catholic Agency for Overseas Development (CAFOD) (RCN 1160384) of Romero House, 55 Westminster Bridge Road, London, SE1 7JB to be used for its general charitable purposes and I direct that the receipt of the treasurer or duly authorised officer shall be a sufficient discharge to my executors.

#### A cash amount or specific gift:

I give to the Catholic Agency for Overseas Development (CAFOD) (RCN 1160384) of Romero House, 55 Westminster Bridge Road, London, SEI 7JB the sum of [£amount/the specific gift of my item] to be used for its general charitable purposes and I direct that the receipt of the treasurer or duly authorised officer shall be a sufficient discharge to my executors.

### Notes

Make a note of any other information or instructions you want to make known. Here are some things you might want to consider:

- If you have pets, who would you like to look after them and how should this be paid for?
- Do you have any preferences regarding your funeral arrangements?
- What would you want to happen to your gift if the intended recipient passes away during your lifetime?
- Have you made any substantial gifts in the last seven years? These may have Inheritance Tax implications.
- Are there any questions you want to ask your Will-writer?
