

**Hagerty Drivers Club Sweepstakes
Official Rules**

Hagerty Drivers Club Sweepstakes ("Sweepstakes") begins at 12:00:01 AM Central Standard Time ("ET") on 4/3/2026, and ends at 11:59:59 PM ET on 4/26/2026, ("Sweepstakes Period") which consists of one (1) Grand Prize Drawing and four (4) Weekend Prize entry periods, which are outlined in the Drawing Chart.

The computer clock of Sponsor is the official time-keeping device in the Promotion.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES TO THESE OFFICIAL RULES.

Use a DIY benefit: Log in or create your account to [Hagerty Drivers Club | Classic Car Club Membership](#) and use a benefit to receive fifty (50) entries. DIY benefits include digital library from Chilton, discounts from our partners, watch a video or read an article on Hagerty media, or simply just Ask Hagerty. There is a limit of fifty (50) entries via this method of entry, per day, for each Sweepstakes Entry Period.

This Sweepstakes is not sponsored, endorsed, administered by or associated with Meta. By entering, you are providing your information to Sponsor and not to Meta.
