

**Hagerty Drivers Club Sweepstakes  
Official Rules**

**NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. Hagerty Drivers Club Sweepstakes ("Sweepstakes") begins at 12:00:01 AM Central Standard Time ("ET") on 6/26/2026, and ends at 11:59:59 PM ET on 6/30/2026, ("Sweepstakes Period").**

**The computer clock of Sponsor is the official time-keeping device in the Promotion.**

**BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES TO THESE OFFICIAL RULES.**

- 2. ADMINISTRATOR:** Arrowhead Promotion & Fulfillment Co., Inc., 1105 SE 8th St, Grand Rapids, MN 55744 ("Administrator").
- 3. ELIGIBILITY:** Hagerty Drivers Club Sweepstakes (the "Sweepstakes") IS OPEN AND OFFERED ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND DISTRICT OF COLUMBIA, CANADA (VOID IN QUEBEC) WHO ARE (21) YEARS OF AGE AND OLDER OR WHO HAVE REACHED THE AGE OF MAJORITY IN THEIR STATE OF RESIDENCE. 6. **DRAWING AND WINNER NOTIFICATION:** On or about July 5, 2026, eight (8) winners will be randomly selected from among all valid entries received during the Sweepstakes Entry Period.

Potential Winners will receive notification by Administrator or Sponsor via email on or about the day of the random drawing.
