

## **JSX LIFE IS BEAUTIFUL FESTIVAL GIVEAWAY OFFICIAL RULES**

NO PURCHASE NECESSARY OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES 21 YEARS OF AGE AND OLDER VOID WHERE PROHIBITED OR RESTRICTED BY LAW
