THE OUTREACH PROGRAM INCLUDES THE FOLLOWING: ON-LINE OUTREACH, BOOKLETS ON VEGETARIAN EATING AND FACTORY FARMING, DISTRIBUTION OF VEGETARIAN STARTER GUIDES, HUMANE EDUCATION, CONDUCTED VEG-FEST PROGRAMS. THE HUMANE LEAGUE ALSO CONDUCTS CAMPAIGNS EDUCATING THE PUBLIC AGAINST FACTORY FARMING CRUELTY.
