#### Q. How is Beauty Glow<sup>™</sup> different from other beauty oils?

A. Beauty Glow is a newly formulated product that offers a broader spectrum of cannabinoids and is designed to provide a more mindful approach to beauty. Beauty Glow incorporates full-spectrum hemp extract with 600 mg of CBD, which includes a wider range of cannabinoids, terpenes, and other beneficial compounds naturally found in the hemp plant. This allows for the entourage effect, enhancing the overall efficacy of the product.

Additionally, Beauty Glow leverages DeepSpectra<sup>®</sup> technology to harness the full potential of the hemp plant and deliver a more potent, bioavailable formula. We made this change to create a more complete and effective product, drawing from multiple parts of the hemp plant and using strong genetics from population hemp plants grown from non-feminized seeds, rather than clonal hemp plants. This approach ensures a rich, diverse cannabinoid profile, enhancing the synergy of the plant's natural compounds and promoting healthy-looking skin.

Another key feature of Beauty Glow is the inclusion of powerful essential oils sourced directly from our farms. These oils, known for their potency, complement the hemp extract and work synergistically to nourish and beautify the skin. Our commitment to sourcing both hemp and essential oils from our own farms, and Seed to Seal<sup>®</sup> partner farms, ensures that every product is made with the highest-quality ingredients and reflects our dedication to sustainability and transparency.

#### Q. How does this product provide a "Beauty Glow"?

A. Beauty Glow includes ingredients that deeply moisturize and promote an even-looking skin tone and a youthful appearance.

#### Q. What benefits does Beauty Glow provide over the previous CBD products?

- A. Beauty Glow offers several unique benefits:
  - Full-spectrum hemp: Unlike Beauty Boost (CBD isolate), Beauty Glow uses full-spectrum hemp for a broader range of cannabinoids, enhancing the entourage effect for better results.
  - **DeepSpectra technology:** This patents-pending technology boosts the bioavailability of the hemp extract, making the formula more potent and effective.
  - Stronger cannabinoid profile: Beauty Glow is made from population hemp plants (not clonal), ensuring a richer and more diverse cannabinoid profile for superior skin benefits.
  - Essential oils: This product includes premium essential oils sourced from our farms, working synergistically with the hemp extract to nourish and beautify the skin.
  - **Sustainable sourcing:** The botanicals used are sourced from our own and Seed to Seal partner farms, ensuring the highest quality and commitment to sustainability.

#### Q. What benefit does cannabis extract specifically add to Beauty Glow?

A. The cannabis extract in Beauty Glow allows the user to topically apply cannabinoids.

#### Q. How much CBD is in Beauty Glow?

A. Each bottle of Beauty Glow contains 600 mg of full-spectrum CBD.

#### Q. Where should Beauty Glow be applied?

A. When using Beauty Glow as a beauty oil, warm 1 dropper of oil in clean palms morning or night and gently press into clean, dry skin on the face and neck, gently massaging in upward motions.

When using Beauty Glow as a beauty booster for the body, add 1–2 droppers of oil to your body lotion before application.

## Q. Can children use Beauty Glow?

- A. Beauty Glow is not intended for use on children under the age of 2 years old, mainly because it contains black seed oil (contraindicated for topical use in children under 2) and CBD. While there is no supporting documentation for CBD being safe or unsafe in children older than 2 years, it has been used in various products on the market, some of which are meant for children. Children have seen the following side effects from CBD products:
  - Sleepiness
  - Decreased appetite
  - Irritability
  - Restlessness

If a child shows side effects from the use of CBD products, discontinue use of the product. If you are unsure about using CBD products with a child, please consult a health care professional before use.

#### Q. How often should Beauty Glow be applied?

A. When using Beauty Glow as a beauty oil it can be used once per day, either morning or night based on individual preference.

When using Beauty Glow as a beauty booster for the body, add 1–2 droppers of oil to your body lotion before application as often as needed.

#### Q. Is Beauty Glow considered vegetarian and/or vegan friendly?

A. Yes, Beauty Glow is both vegetarian and vegan friendly.

#### Q. Does Beauty Glow include ingredients containing gluten?

A. No gluten-containing ingredients are used in the formulation of Beauty Glow. This product may be manufactured in a facility that uses gluten in other product formulations; however, according to CGMP (current good manufacturing practices), the machinery is cleansed and sanitized between products to prevent contamination. Please speak to your health care provider if you have additional concerns about using this product.

#### Q. Are corn-derived ingredients used in the product formulation?

A. No corn-derived ingredients are used in the formulation of Beauty Glow. This product may be manufactured in a facility that uses corn in other product formulations; however, according to CGMP (current good manufacturing practices), the machinery is cleansed and sanitized between products to prevent contamination. Please speak to your health care provider if you have additional concerns about using this product.

#### Q. Are soy-derived ingredients used in the product formulation?

A. No soy-derived ingredients are used in the formulation of Beauty Glow. This product may be manufactured in a facility that uses soy in other product formulations; however, according to CGMP (current good manufacturing practices), the machinery is cleansed and sanitized between products to prevent contamination. Please speak to your health care provider if you have additional concerns about using this product.

## Q. Are ingredients derived from palm/coconut used in the product formulation?

A. Caprylic/capric triglycerides, also known as fractionated coconut oil, are used in the full-spectrum CBD Beauty Glow formula. Please speak to your health care provider if you have additional concerns about using this product.

## Q. Are ingredients derived from tree nuts used in the product formulation?

A. Other than the inclusion of caprylic/capric triglycerides (fractionated coconut oil), no tree nutderived ingredients are used in the formulation of Beauty Glow. This product may be manufactured in a facility that uses tree nuts in other product formulations; however, according to CGMP (current good manufacturing practices), the machinery is cleansed and sanitized between products to prevent contamination. Please speak to your health care provider if you have additional concerns about using this product.

#### Q. Are ingredients derived from sesame used in the Beauty Glow product formulation?

A. No sesame-derived ingredients are used in the formulation of Beauty Glow. This product may be manufactured in a facility that uses sesame in other product formulations; however, according to CGMP (current good manufacturing practices), the machinery is cleansed and sanitized between products to prevent contamination. Please speak to your health care provider if you have additional concerns about using this product.

## Q. Which essential oils are used in Beauty Glow?

A. Beauty Glow contains Cananga odorata (Ylang ylang) flower oil, Plectranthus amboinicus (Ecuador Oregano) leaf/stem oil, Lippia alba leaf/stem oil, and Lavandula angustifolia (Lavender) oil.

#### Q. How do the essential oils benefit Beauty Glow?

A. The essential oils used in Beauty Glow promote an even-looking skin tone and reduce the appearance of blemishes, fine lines, and wrinkles. They also leave your skin refreshed and glowing while providing terpenes to complement the cannabinoid profile of the whole hemp extract.

#### Q. Can I add more essential oil to Beauty Glow before use?

A. Yes, you can customize your experience by adding desired essential oils to the Beauty Glow product in your hands before application.

#### Q. What is the predominant scent of Beauty Glow?

A. Beauty Glow features a scent of soft floral notes with a hint of fresh herbs.

## Q. Does Beauty Glow contain THC?

A. Yes, our full-spectrum CBD Beauty Glow product contains less than 0.3% THC, verified through testing before being sold.

## Q. Why did you choose to include THC in the new CBD products?

A. We use a full-spectrum hemp extract to capture the full range of cannabinoids naturally present in the plant, including trace amounts of THC. This allows the compounds to work together synergistically, enhancing the overall benefits through the "entourage effect."

#### Q. What part of the Beauty Glow formula is third-party tested?

A. Each lot of our Beauty Glow formula is third-party tested for CBD, THC, solvents, and pesticides.

#### Q. How does the type of CBD used in the new products differ from the ones you previously sold?

A. Our previous CBD products offered CBD isolates, whereas our new CBD products are formulated using a full-spectrum whole hemp source, containing all cannabinoids present in the hemp plant.

#### Q. Why did you choose to use DeepSpectra in the new CBD products?

A. We chose to incorporate DeepSpectra in our full-spectrum CBD products to differentiate them from others on the market and enhance their effectiveness. DeepSpectra's patents-pending technology allows us to deliver the added topical benefits of DeepSpectra® Lavender Melissa, providing a unique, synergistic boost to the overall experience.

#### Q. Why is the color or smell different from my previous bottle of Beauty Glow?

A. Natural variance can occur in any product and may be caused by many different factors, including time or location of harvest, amount of sunlight or water, etc. While the variance can affect the aroma or color, all products are tested to ensure they meet our strict standards before being offered for purchase.

Our new CBD products may experience more frequent fluctuations than other products because a formula featuring whole hemp, instead of an isolate, will vary more greatly. Moreover, the CBD level of each hemp plant will vary, and through testing, we will determine if more or less hemp is needed to meet all label claims. With these systems in place, you can rest assured that the product has been thoroughly tested and each bottle, regardless of color or scent variation, will meet the labeled CBD claim and be below the 0.3% THC threshold every time.
