

# ImmuPro™ FAQ



## **Q. Why was ImmuPro herbal supplement reformulated?**

A. We reformulated it due to sourcing issues with the strawberry powder ingredient, which is considered a 1:1 change. Our members may notice a change to the ingredient listing where “Strawberry (*Fragaria chiloensis*) fruit powder” was changed to “Strawberry (*F. x ananassa*).” In addition to the strawberry powder source, the melatonin amount was adjusted from 4.2 mg to 4 mg.

## **Q. How often should I take ImmuPro herbal supplement?**

A. Take 1 chewable tablet once daily at bedtime. Don't exceed the recommended dosage. Please adhere to all cautions and warnings listed on the product label for optimal benefit.

## **Q. What is ImmuPro herbal supplement's shelf life?**

A. It has a two-year shelf life.

## **Q. Is ImmuPro herbal supplement vegetarian and/or vegan friendly?**

A. Based on the information provided by our manufacturer, This product is both vegan and vegetarian friendly.

## **Q. Does ImmuPro herbal supplement contain ingredients derived from dairy or egg?**

A. There are no dairy- or egg-derived ingredients used in the formulation. However, this product may be manufactured in a facility that uses dairy or egg in other product formulations. Though dairy and/or egg may be processed in the same facility, please rest assured that according to Current Good Manufacturing Practices (CGMPs), the machinery is cleansed and sanitized between productions to prevent contamination. ## **Q. Are any ingredients containing gluten included in the ImmuPro formula?**

A. There are no gluten ingredients. However, this product may be manufactured in a facility that uses gluten in other product formulations. Though gluten may be processed in the same facility, please rest assured that according to Current Good Manufacturing Practices (CGMPs), the machinery is cleansed and sanitized between productions to prevent contamination. ## **Q. Are corn-derived ingredients present in the ImmuPro formula? Are they GMO?**

A. Yes, both dextrose and maltodextrin are present and are both derived from non-GMO corn. If you have additional concerns about the use of this product, we encourage you to speak to your health care provider.

## **Q. Are soy-derived ingredients present in the ImmuPro formula? Are they GMO?**

A. No, there are no soy-derived ingredients used in the formula. However, this product may be manufactured in a facility that uses soy in other product formulations. Though soy may be processed in the same facility, please rest assured that according to Current Good Manufacturing Practices (CGMPs), the machinery is cleansed and sanitized between productions to prevent contamination. If you have additional concerns about the use of this product, we encourage you to speak to your health care provider.

**Q. Are any ingredients derived from palm/coconut present in the ImmuPro formula?**

A. There are no palm/coconut derived ingredients used in the formula. However, this product may be manufactured in a facility that uses palm and/or coconut in other product formulations. Though there may be palm or coconuts processed in the same facility, please rest assured that according to Current Good Manufacturing Practices (CGMPs), the machinery is cleansed and sanitized between productions to prevent contamination. If you have additional concerns about the use of this product, we encourage you to speak to your health care provider.

**Q. Are ingredients derived from tree nuts present in the ImmuPro formula?**

A. There are no tree nut-derived ingredients used in the formula. However, this product may be manufactured in a facility that uses tree nuts in other product formulations. Though there may be tree nuts processed in the same facility, please rest assured that according to Current Good Manufacturing Practices (CGMPs), the machinery is cleansed and sanitized between productions to prevent contamination. If you have additional concerns about the use of this product, we encourage you to speak to your health care provider.

**Q. Are any ingredients derived from sesame present in the ImmuPro formula?**

A. There are no ingredients derived from sesame used in the formula. Please be aware, however, that this product may be manufactured in a facility that uses sesame in other product formulations. Though there sesame may be processed in the same facility, please rest assured that according to Current Good Manufacturing Practices (CGMPs), the machinery is cleansed and sanitized between productions to prevent contamination. If you have additional concerns about the use of this product, we encourage you to speak to your health care provider.

**Q. What is the country of manufacture for ImmuPro herbal supplement?**

A. It is manufactured within the United States.

**Q. What color are the ImmuPro chewable tablets?**

A. ImmuPro tablets are red with white, tan, and black specks.

**Q. How is ImmuPro herbal supplement packaged?**

A. This product comes in a 120 cc white high-density polyethylene (HDPE) bottle with a wide-mouth round cap. A desiccant pack and cotton strip are included inside the pressure-sensitive seal.

**Q. When is the best time of day for consumption?**

A. Before bed is the recommended time to take ImmuPro herbal supplement. Do not exceed 1 tablet per day. Please adhere to all cautions and warnings listed on the product label for optimal benefit.

**Q. Should ImmuPro tablets be taken with or without food?**

A. If you experience stomach sensitivity, taking ImmuPro tablets with food may help. ImmuPro tablets can be taken once daily as needed at bedtime. If you have additional concerns about the use of this product, we encourage you to speak to your health care provider.

**Q. How much melatonin is in each serving of ImmuPro herbal supplement?**

A. A single tablet of ImmuPro herbal supplement contains 4 mg of melatonin.
