Q. Can I ingest this proprietary blend?

A. Yes, Season Essentials blend can be ingested. Dilute 1–2 drops with 1 drop carrier oil and place under your tongue or in a capsule up to three times daily.

Q. How long can I diffuse this exclusive Young Living blend?

A. You can diffuse Season Essentials essential oil blend for up to 1 hour 3 times daily.

Q. Do I need to dilute this blend before topical application?

A. Yes, when using Season Essentials blend topically, dilute 1 drop in 2 drops of carrier oil.
