



## VISAYAS & MINDANAO EXCLUSIVE: TOP ENROLLER PROGRAM

### *FREQUENTLY ASKED QUESTIONS*

- 1. Q:** Who can join the USWAG Visayas & Mindanao Top Enroller Program?  
**A:** Open to all existing and new YLPH members until July 15, 2023, with a registered address in Visayas and Mindanao
  
- 2. Q:** How do we determine USWAG Visayas & Mindanao Top Enroller Program?  
**A:** The address registered in the member's account should be within the Visayas and Mindanao area.
  
- 3. Q:** Why is the incentive only open to Visayas & Mindanao members?  
**A:** The USWAG Visayas & Mindanao Top Enroller Program was created to support the growing community of enrollers in Visayas and Mindanao and help increase the enrollee – enroller ratio.
  
- 4. Q:** When is the program period?  
**A:** The USWAG Visayas & Mindanao Top Enroller Program is from August 1, 2023 to September 30, 2023.
  
- 5. Q:** How to join the USWAG Visayas & Mindanao Top Enroller Program?  
**A:** Register through this JotForm link: <https://bit.ly/USWAGRegistration>. The registration is open from July 1 to 15, 2023.
  
- 6. Q:** Why is there a requirement of 3 minimum enrollments per month?  
**A:** This is to ensure consistency in enrolling month over month.

7. Q: Are reactivations included as valid enrollments?  
A: Only those members whose accounts have been dropped after 24 months will be counted.
  
8. Q: Which enrollment kits are valid to enroll in this incentive?  
A: All Philippine enrollment kits are valid (Premium Experience Sets and Special Enrollment Sets/MEO).
  
9. Q: How will members know their existing rank?  
A: There will be a bi-monthly and monthly announcement of qualifiers.
  
10. Q: What will happen if there is a tie in the number of enrollees?  
A: The member with the earliest date of enrollment will win the spot in the leaderboard.
  
11. Q: What would happen if an enrollee refused/returned the kit?  
A: Specific to the USWAG Visayas & Mindanao Top Enroller Program, the enrollee will not be counted/credited to the enroller by the end of the commission month.
  
12. Q: How will be the crediting of enrollees for enroller change?  
A: The enrollee will be credited to the new enroller by the end of the commission month.
  
13. Q: When is the announcement of the winners?  
A: Announcement will be on October 2023. The final date of the announcement of winners will be communicated separately.
  
14. Q: Is the prize convertible to cash or products? Or Transferrable?  
A: No. All Prizes are non-convertible to cash and non-transferrable as well.

15. Q: What are the requirements to qualify as part of the Top 100.  
A: Basic qualification is to be on Essential Rewards (ER) with 100 PV On-the-Ground (OTG) and minimum of 3 enrollments per month during the program duration. The total number of enrollments from August to September 2023 will determine which tier the member has won.  
  
An additional requirement is needed to reach the Top 1 to 20 spots. A minimum of 15 enrollments in total is required.

16. Q: Are my enrollments required to be on ER?  
A: All enrollments for USWAG Visayas & Mindanao Top Enroller Program can be on Essential Rewards (ER) or Quick Order (QO).

17. Q: What if I have multiple Essential Reward orders for the month, will that be qualified to complete the 100 PV OTG requirement?  
A: Yes. Kindly reach out to MS to process your 2<sup>nd</sup> ER for the month.

18. Q: Are all of my enrollees required to be from Visayas and Mindanao too?  
A: Any enrollment within the Philippine market will be considered for USWAG Visayas & Mindanao Top Enroller Program.
