

Official Rules: Science Museum of Minnesota December 2023 Holiday Giveaway

Eligibility: You must be a legal resident of the United States, 18 years or older at the time of entry, and living in a jurisdiction where this incentive is not restricted or prohibited by law ("Eligible Participants"). Employees and immediate family members of employees of The Science Museum of Minnesota (SMM), advertising and promotional agencies, any other prize sponsor, and any entity involved in the development, production, implementation, administration or fulfillment of this Incentive together with SMM, are not eligible to participate or win.
