## Participation procedures:

In the period from May 12th to June 12<sup>th</sup> 2025, all Internet users who have completed the form in the fields indicated as mandatory, including the address e-mail, you will be given the opportunity to participate in this Contest as described below.

To participate, the user must indicate in the appropriate fields the required descriptions related to their trip with their Ducati Multistrada V4 by adding photo and/ or video content to documentation of the trip.

The Promoter Company may decide, at its sole discretion, not to admit to the Contest, and therefore not to allow the publication of photos and/ or videos of the trip that it considers to be vulgar, offensive, contrary to the norm, including those of circulation or otherwise detrimental to the rights or image of oneself or others.

# Selection by jury

<u>Within June 30th 2025</u> In the presence of a notary or the responsible for consumer protection and public trust of the Chamber of Commerce, the content received by users will be submitted to the evaluation of a jury composed of experts chosen by the Promoter ("Jury").

The Jury will review and analyse the content received and choose the winners from the following 6 categories: the most adventurous trip, the longest trip in kilometers, the most memorable solo trip, the most memorable group trip, the trip of a member of a Ducati Official Club most memorable, and the most particular trip, according to the following criteria:

- quality of materials and content
- particularities and originality of the itinerary
