F: Details:

This vehicle has the following factory options and accessories:

Cruise control, Recaro sports seats, sports steering wheel, Xenon lighting, front suspension cross bar, TÜV approved lowering set GM5-D262/-D263 with Bilstein B16-PSS10 adjustable shock absorbers, gearbox 2008 newly fitted, computer, and 3-point belt. Crossbar front suspension and original Kinesis K28 rims. Original spare wheel, steering wheel & airbag are available.

G: Explanation of the valuation:

This vehicle has been exported to Japan after 1st registration in Germany, maintenance stickers during this period are present. After that, the vehicle was converted in Belgium, and commissioned by the then owner in 2007 at 107,065 km, into an RS-style replica with original parts. Performed by AP Car Design Göttingen, a renowned Porsche specialist in Germany. Values of an original RS version are well above 180,000 euros. About 5,000 km ago, an engine overhaul and tune-up to 310 HP was carried out. Documentation about this has been viewed and verified. Normal traces of light use have been observed according to age. These aspects have been taken into account in arriving at the valuation, supported by value and market research.
