Ultra Guard Paint Sealant 2-year Limited Warranty

Warranty: American Automotive Chemical Corporation warrants for a period of 2 years, to the original owner of a new vehicle that should the exterior painted surfaces, excluding metal trim and chrome, treated with Ultra Guard paint Sealant be damaged by weather-induced cracking, fading, oxidizing, flaking or loss of gloss, American Automotive Chemical Corporation will repair the damaged area free of charge to the customer.

Exceptions, Limitations, and Exclusions:

The Ultra Guard Paint Sealant warranty does not apply:

- A. to paint damage caused by stone abrasion, accident damage, corrosives, acid, exterior paint chipping, or any acts of the owner and/or operator which would cause damage or deterioration to the painted surfaces.
- B. to paint damage or deterioration caused by alteration, resurfacing, painting or washing of the painted surface with a solvent, abrasive or acid which would cause the removal of the Ultra Guard Sealant.
- C. to damage of painted surfaces which were the result of manufacturers' defects or manufacturing imperfections.

Ultra Guard Interior Fabric Protector 3-year Limited Warranty

Warranty: American Automotive Chemical Corporation warrants to the original owner of a new pleasure vehicle for a period of 3 years, that interior fabric cushions or interior fabric trim coated with the Ultra Guard Fabric Protector will not be permanently stained or soiled by water, soft drinks, alcoholic beverages, dairy products, tomato juice, ketchup, coffee, or urine. Protected areas include cloth, velour or fabric areas and do not include vinyl, plastic, leather or other nonfabric areas of the interior. In the event a legitimate claim exists, American Automotive Chemical Corporation will clean or repair the affected area free of charge to the customer.
