- Seller agrees and consents to the sale of his vehicle subject to the terms, conditions and commissions as stated here and/or contained in the CONSIGNMENT INFORMATION AND SELLING AGREEMENT. Seller authorizes Kruse to release the above vehicle to the buyer on the basis of the method of payment noted on this document and agrees to rely only upon the buyer for payment, thereby releasing Kruse from any and all legal obligation for collection, attorney fees, or any costs and/or expenses connected with this sale.
- Payment for this vehicle is to be immediate and made directly by the buyer to the seller with either party paying the Kruse commission. Buyer agrees to pay all required sales tax, use tax, registrations, processing of other necessary fees known to be due at this time or later discovered to be due in connection with this sale. Buyer agrees to tender payment in good, acceptable funds according to the terms of sale and bidder requirements.
- Buyer hereby assures Kruse that he purchased the described article in good faith, relying entirely upon his own examination. Buyer acknowledges that all sales are final and "as is" without warranty of vehicle history, condition, title, options, specifications, and/or merchantability unless otherwise agreed to in writing by an officer of Kruse, Inc. Buyer accepts responsibility and liability for the vehicle purchased as of the fall of the hammer and agrees to reimburse Kruse and or the seller for any expenses resulting from moving, storing, and/or liability of any type prior to release of the vehicle to buyer.
- Buyer and seller agree that Kruse shall assume no liability for loss, theft or damage of any type to the vehicle, its contents, or components at any time. Buyer and seller agree to save Kruse, their agents, and their employees harmless from any claims for injury or property loss damage arising out of said purchase. Buyer and seller should maintain their own insurance. Kruse provides no such insurance on any vehicle or item.
- The seller shall provide an accurate odometer statement as required by law and shall be solely responsible for any inaccuracies therein.
- When an item is sold with reserve, the auctioneer may bid on the seller's behalf to reach the reserve price. If a seller offers to lower his reserve price and Kruse chooses to sell at the lowered price, the original, normal reserve commission rate/formula will still apply.
- If buyer or seller sues Kruse and does not prevail, buyer or seller will reimburse Kruse for all its legal fees and expenses connected with said suit.
