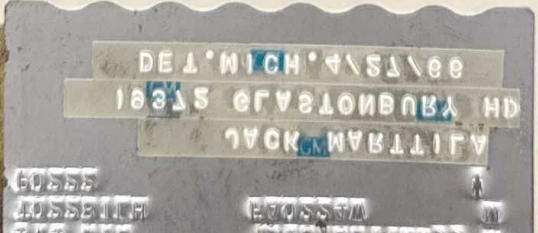

The insurance will (in absence of default on installment payments) remain in force, subject to the terms of the group policy, until discharge of such indebtedness. Any insurance proceeds becoming payable will be applied to reduce or extinguish the indebtedness. The amount of insurance will be the amount owing from time to time under this contract not exceeding \$10,000, nor \$10,000 in the aggregate in respect to all indebtedness as to which the Buyer is insured under the group policy. It is expressly agreed between Buyer and Seller that the provisions on the reverse side hereof constitute a part of this Security Agreement.
