

JB Hi-Fi Obsession competition (“Competition”)

TERMS AND CONDITIONS

General

4. Competition commences on 6th July 2026 at 09:00am AEST and ends 4th October 2026 at 11:59pm AEDT (Competition Period).

Who can enter

5. Entry into the Competition is open to all residents of Australia who have fulfilled the requirements set out in these Terms and Conditions.
