

## **JB Hi-Fi Indiana Jones Xbox Competition (“Competition”)**

### **TERMS AND CONDITIONS**

#### **General**

1. The Promoter is JB Hi-Fi Group Pty Ltd ABN 37 093 114 286, of 60 City Road Southbank, VIC 3006.
2. By submitting an entry into this Competition “you” acknowledge and agree to these Terms and Conditions.

#### **Who can enter**
