Matters from Race:

Race Director Incident Determinations

The Race Director investigated the incident involving Car 35, Ash Walsh, and Car 49, Jordan Boys, at Turn 21 on Lap 39 and determined the matter did not warrant referral to the Stewards.

Stewards' Decisions - Penalties imposed

Following a post-race investigation and an admission of a breach of Schedule B3, Article 4.2 (Yellow flag) by Car 16, Bryce Fullwood, the Stewards imposed the penalty of the addition of 15 seconds to Car 16's race time. Additionally, the Stewards invalidated Car 16's lap time for Lap 41.

During the Race, the Stewards observed fuel being spilled during the refuelling phase of the Pit Stops for both Car 38, Will Brown, and Car 88, Justin Ruggier. After the Race, the Stewards conducted an inquiry into these incidents. The evidence was that despite the care taken to ensure safe and compliant refuelling for the Race by the Competitor, and the requirement for it to use the refuelling equipment of another team, and that the refuelling equipment provided by that other team was not fully compatible with their cars. Therefore, no breach of the rules was established.
