## **Supercars Competition Terms and Conditions**

## BP Adelaide Grand Final Getaway

- 1. Information on how to enter forms part of these terms and conditions.
- 2. Entry is only open to Australia residents aged 18 years or over at the start of the Promotional Period.
- 3. The competition commences at 9am AEST on 11 September 2025 and closes at 5pm (AEDT) on 7<sup>th</sup> November 2025 (the *Promotional Period*).
- 4. To enter, entrants must:
  - (a) visit Supercars.com/winwithbp; and
  - (b) complete the entry form by submitting their full name, date of birth, email address, phone number and post code.
