Matters from Qualifying Race 2:

Race Director Incident Determinations

There were no DRD determinations.

Stewards' Decisions - Penalties imposed

The Stewards imposed a \$350.00 Fine on Car #21, Jack Smith for a breach of Rule D11.4.2 (Pit Lane Speed Limit) for exceeding the Pit Lane Speed at Pit Entry (46kph)

The following Cars had their lap times deleted for exceeding Track Limits at Turn 2:

- Car #49, Jordan Boys
- Car #56, Jake Kostecki
- Car #10, Brenton Grove

The Stewards imposed a Penalty on Car #38, Will Brown for a Breach of Rule D6.1.11 Causing a Red Flag. Car #38 was not permitted to take any further part in that qualifying Session and had their fastest lap deleted

Matters from Race 1:

Race Director Incident Determinations

The Race Director received a request for investigation from Eggleston Motorsport Australia Pty Ltd regarding an incident between Car #88 and Car #99 on Lap 18 at Turn 3. Following a review of HawkEye vision, the Race Director determined that neither driver was wholly or predominately to blame for the incident.

Stewards' Decisions - Penalties imposed

The Stewards imposed a 5 second Post Race Time Penalty of Car #28, Zane Goddard for causing contact with Car #27 Tyler Everingham at Turn 6 on Lap 2.
