### **STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update (FINAL): Sunday, 16 September 2018 at 1745hrs.**

#### ***Matters from Race 2:***

##### *Race Director Incident Determinations*

There were no RD determinations.

##### *Stewards' Decisions – Penalties imposed*

During Race 2 the Stewards imposed the following penalties for Breaches of Schedule B2 Article 2.1.1 – Careless Driving;

- 15 seconds Time Penalty on Car #63, Dominic Storey for contact with Car #18, Matt Chahda at Turn 12.
- Post-Race Pit Lane Penalty (26 seconds) on Car #51, Brenton Grove for contact with Car #49, Jordan Boys at Turn 11.

The Stewards imposed a 15 seconds Time Penalty on Car #23, Dean Fiore for breach of Rule D10.2.10.2 Safety Car Procedures (weaving after Safety Car's Flashing Lights were extinguished).

Following a post-session investigation and an admission by Car #55, Kurt Kostecki of a breach of Schedule B2 Article 2.1.1 – Careless Driving (Car #55 was found to have made contact with Car #26, Garry Jacobson causing Car #26 to lose multiple positions.). The Stewards imposed a Fifteen (15) Second Post Race Time Penalty for Car #55 in Race 2.

### **STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update #3: Sunday, 16 September 2018 at 1145hrs.**

#### ***Matters from Qualifying Race 2:***

##### *Race Director Incident Determinations*

There were no RD determinations.

##### *Stewards' Decisions – Penalties imposed*

The RD conducted a post Session investigation into an incident involving Car #26, Garry Jacobson and Car #44, Chris Pither, following a review of Judicial Camera Footage from Car #26, Timing Data and Supercars Telemetry Data the RD determined Car #26 breached Schedule B2 Article 2.1.1 – Careless Driving for impeding Car #44. The Stewards imposed a three (3) Grid Spot Penalty for Race 2 of Round 5 in the 2018 Dunlop Super2 Series.

#### **Matters from Qualifying Race 1:**

##### Stewards' Decisions – Penalties imposed

#### **Matters from Race 1:**

##### Race Director Incident Determinations

Following a request from Eggleston Motorsport Pty Ltd, the RD investigated an alleged incident involving Car #54, Nathan Morcom and #67, Shae Davies at Turn 1. Having reviewed the Judicial Camera Footage of Car #54 and #67 as well as the Television Broadcast, the matter does not warrant being referred to the Stewards.

Following a request from Garry Rogers Motorsport, the RD investigated an incident that alleged Car #38, Will Brown overtook two Cars under Yellow Flags between Turn 4 and 5. Having reviewed the Judicial Camera Footage from Car #38, the matter didn't warrant being referred to the Stewards

##### Stewards' Decisions – Penalties imposed

During Race 1 the Stewards imposed the following penalties for Breaches of Schedule B2 Article 2.1.1 – Careless Driving;

- 15 seconds Time Penalty on Car #26, Garry Jacobson for contact with Car #57, Brodie Kosteki at Turn 12 on Lap 3.
- 15 seconds Time Penalty on Car #54, Nathan Morcom for contact with Car #50, Ricky Capo at Turn 15.
- 5 second Time Penalty on Car #55, Kurt Kosteki for contact with Car #23, Dean Fiore at Turn 1.
- Pit Lane Penalty on Car #38, Will Brown for contact with Car #44, Chris Pither at Turn 2.
- Post-Race Pit Lane Penalty (26 seconds) on Car #23, Dean Fiore for contact with Car #55, Kurt Kosteki at Turn 4.

The Stewards imposed a Pit Lane Penalty on Car #50, Ricky Capo for a Breach of Rule D8.3.7 Start Procedure, (Team Personnel not clearing the grid at the One Minute Board).

#### **Competitors Authorised Representative Briefing**

The Stewards issued a penalty of \$500 on Kali Motorsport for Breach of Rule D4.1.3, non-attendance at Competitors Authorised Representative Briefing.
