STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update #2: issued Saturday 21 October 2017 at 1800hrs.

Matters from Race 21:

Race Director Incident Determinations

The IO investigated the Incident involving contact between Car #5, Winterbottom/Canto, and Car #8, Percat/Jones, at Turn 4 on Lap 68 during the Race and determined they did not warrant referral to the Stewards.

Stewards' Decisions – Penalties imposed

The Stewards imposed the following penalties during the Race:

- A 15 second Time Penalty on Car #88, Whincup/Dumbrell, for a driving infringement, contact with Car #55, Mostert/Owen, at Turn 2 on Lap 28;
- A PLP on Car #5, Winterbottom/Canto, for a pit lane infringement, unsafe pit release;
- A 15 second Time Penalty on Car #99, Wood/Pither, for a driving infringement, contact with Car #34, Moffat/Muscat, at Turn 11 on Lap 63;
- A 15 second Time Penalty on Car #12, Coulthard/D'Alberto, for a driving infringement, contact with Car #8, Percat/Jones, at Turn 11 on Lap 72.

Following a post-race investigation and admission of Careless Driving by Car #7, T Kelly/Le Brocq, contact with Car #33, Tander/Golding, the Stewards imposed the penalty of the loss of 25 Championship Points on Car #7, T Kelly/Le Brocq.
