Matters from Race 3:

Race Director Incident Determinations

The Race Director investigated the following Incidents during the Race and determined they did not warrant referral to the Stewards:

- Incident involving Car #44, Dylan O'Keeffe, and Car #55, Kurt Kostecki, at Turn 4;
- Incident involving Car #35, Ash Walsh, and Car #21, Jack Smith, at Turn 9.

Stewards' Decisions - Penalties imposed

The Stewards imposed the following penalties during the Race:

- A PLP on Car #35, Ash Walsh, for a breach of the start procedures (Team member/s working on the Car after the 1-minute board);
- A PLP on Car #47, Joel Heinrich, for consistently overusing the Turn 2 kerbs.

Matters from Race 2:

Race Director Incident Determinations

During the Race, the Race Director investigated the incident involving Car #5, Thomas Randle, at Turn 2 and determined the incident did not warrant referral to the Stewards as there was no breach of the rules.

After the Race, the Race Director investigated Car #33's pit stop and determined that the incident did not warrant referral to the Stewards as there was no breach of the rules.

Stewards' Decisions - Penalties imposed

Following a Stewards Hearing and finding of a breach of parc ferme rules, the Stewards disqualified Car #10, Brenton Grove, and Car #55, Kurt Kostecki, from Race 2.
