Matters from Race 2:

Race Director Incident Determinations

The RD investigated the following matters during the Race and determined that none of them warranted referral to the Stewards because no breach of the Rules was observed or no Driver was wholly or predominantly to blame:

- An Incident on Lap 5 at Turn 1 involving contact between Cars #15 and #88
- An Incident on Lap 17 at Turn 11 involving contact between Cars #44 and #28

The Stewards determined that Car #18 had breached Schedule B3 Signalling Article 3.4.1 (Black Flag) and imposed a Fine of \$5,000 with \$3,000 suspended until the 31st December 2020.
