Matters from Qualifying Race 2

Deputy Race Director Incident Determinations

There were no determinations.

Stewards' Decisions – Penalties imposed

Following a post-session investigation and an admission by Car #23, Dean Fiore of a breach of the Drivers and Competitors Instructions (Car #23 was found to have crossed the Chevron at Pit Entry). The Stewards imposed a Fine of \$500.00.

Following a post-session investigation and an admission by Car #99, Mason Barbera of a breach of Rule D11.5.10.3 (Car #99 was found to have entered Pit Lane after the Chequered Flag). The Stewards imposed a Fine of \$500.00.

Following a post-session investigation and an admission by Car #54, Nathan Morcom of a breach of the Drivers and Competitors Instructions (Car #54 was found to have crossed the Chevron at Pit Entry). The Stewards imposed a Fine of \$500.00.

Following a post-race investigation and an admission by Car #99, Mason Barbera of a breach of Schedule B2 Article 2.1.1 – Careless Driving (Car #99 was found to have impeded Car #62, Alex Rullo). The Stewards imposed Three (3) Progressive Grid Spot Penalty starting from Race 2.

Following a post-race investigation and an admission by Car #67, Shae Davies of a breach of Schedule B2 Article 2.1.1 – Careless Driving (Car #67 was found to have impeded Car #62, Alex Rullo). The Stewards imposed Three (3) Progressive Grid Spot Penalty starting from Race 2.

Matters from Race 1

Deputy Race Director Incident Determinations

There were no determinations.

Stewards' Decisions – Penalties imposed

The Stewards imposed a Pit Lane Time Penalty (25 seconds) on Car #63, Dominic Story for breach of Schedule B2 Article 2.1.1 – Careless Driving for causing contact with Car #10, Brenton Grove at Turn 5 on Lap 21.

Following a post-session investigation and an admission by Car #21, Jack Smith of a breach of Schedule B2 Article 2.1.1 – Careless Driving (Car #21 was found to have made avoidable contact, causing Car #54, Nathan Morcom to spin and continue). The Stewards imposed a penalty of Fifteen (15) Second Post Race Penalty for Car #21 in Race 1.

Following a post-session investigation and an admission by Car #55, Kurt Kostecki of a breach of Schedule B2 Article 2.1.1 – Careless Driving (Car #55 was predominately to blame for incident which resulted in Car #21, Jack Smith impacting the wall). The Stewards imposed a Fifteen (15) Second Post Race Penalty for Car #55 in Race 1.

Following a post-session investigation and an admission by Car #38, Will Brown of a breach of Schedule B2 Article 2.1.1 – Careless Driving (Car #38 was wholly to blame for incident with Car #55, Kurt Kostecki). The Stewards imposed a Five (5) Second Post Race Penalty for Car #38 in Race 1.

Following a request by Brad Jones Racing the RD conducted a post Session investigation into an Incident involving Car #63, Dominic Storey and Car #8, Zane Goddard, the RD determined Car #63 breached Schedule B2 Article 2.1.1 – Careless Driving for impeding Car #8. The Stewards imposed Three (3) Progressive Grid Spot Penalty for Car #63 from Race 1 of Round 4 in the 2018 Dunlop Super2 Series onwards.

Stewards' Decisions – Penalties imposed

Following a review of Car #15, Adam Marjoram's Judicial Camera Footage, Car #15 was found to have failed to observe multiple (more than ten) Red Flags displayed around the Race Track. (Breach of Schedule B3 Article 3.2 – Red Flag), In the process, Car #15 failed to slow and overtook Car #50 while Red Flags were displayed and failed to proceed immediately to Pit Lane, continuing for an additional lap of the Race Track. A report from the Timekeepers confirmed the above. The Stewards imposed a Fine of \$10,000 with \$5,000 suspended until 31/12/19 and disqualification from Practice 1 of Round 4 of the 2018 Dunlop Super2 Series.
