### **STEWARDS SUMMARY OF JUDICIAL OUTCOMES, Update #3: FINAL Sunday, 4 March 2018 at 1510hrs.**

#### ***Matters from Race 3 (Sunday 4 March 2018):***

##### *Race Director Incident Determinations*

The Race Director investigated the Incident involving contact between Car #8, Zane Goddard, and Car #67, Shae Davies, and determined the matter did not warrant referral to the Stewards.

##### *Stewards' Decisions – Penalties imposed*

The Stewards imposed the following penalties during the Race:

- a 15 second Time Penalty on Car #23, Dean Fiore, for a Driving Infringement (Careless Driving - contact with Car #67, Shae Davies, at Turn 9);
- a PLP on Car #16, Bryce Fullwood, for overuse of the Turn 2 kerbs (Schedule B2, Article 3.12.1);
- a 5 second Time Penalty on Car #62, Alex Rullo, for a Driving Infringement (Careless Driving – contact with Car #13, Tyler Greenbury, at Turn 9).

#### ***Matters from Race 2 (Saturday 3 March 2018):***

##### *Race Director Incident Determinations*

The Race Director investigated the Incident involving contact between Car #57, Brodie Kostecki, and Car #62, Alex Rullo, and determined the matter did not warrant referral to the Stewards.

##### *Stewards' Decisions – Penalties imposed*

The Stewards imposed the following penalties during the Race:

- a 15 second Time Penalty on Car #10, Brenton Gove, for a Driving Infringement (Careless Driving - contact with Car #49, Jordan Boys, at Turn 5);
- a PLP on Car #18, Matt Chahda, for a Driving Infringement (Reckless Driving – contact with Car #54, Nathan Morcom at Turn 7).

Following an investigation and an admission of Careless Driving (Schedule B2, Article 2.1.1 – contact with Car #15 at Turn 6) by Car #62, Alex Rullo, the Stewards imposed the penalty of 15 second Time Penalty for Race 2 on Car #62, Alex Rullo.

#### **Matters from Race 1:**

##### Race Director Incident Determinations

The Race Director conducted a post-race investigation into the Incident involving contact between Car #49, Jordan Boys, Car #10, Brenton Grove, and Car #63, Dominic Storey at Turn 9 and determined the Incident did not warrant referral to the Stewards because no driver was wholly or predominately to blame for the Incident occurring.

##### Stewards' Decisions – Penalties imposed

Following a post-race investigation and admission of Reckless Driving (Schedule B2, Article 2.1.2) by Car #99, Mason Barbera, the Stewards imposed the penalty of the Loss of 35 2018 Dunlop Super2 Series Points upon Car #99, Mason Barbera.

##### Stewards' Decisions – Penalties imposed

The Stewards imposed a 5 Minute Stop Go Penalty on Car #15, Adam Marjoram, for a breach of the instructions given for the Start Procedure of Qualifying (Authorised Representative briefing – session to start from Pit Lane).

Following an investigation and an admission by MW Motorsport of a breach of Rule D13.6 (Parc Ferme for DS2 – undertaking non-permitted activities), the Stewards imposed the penalty of Disqualification on Car #23, Dean Fiore, and Car #62, Alex Rullo.

Following an investigation and an admission by Car #13, Tyler Greenbury, of a breach of Schedule B3, Article 3.2 - Red Flag, the Stewards imposed the penalty of a fine of \$5000, \$2000 of which is suspended until 31 December 2018, on Car #13, Tyler Greenbury.

### Stewards' Decisions – Penalties imposed

Following investigations and admissions of a breach of Supplementary Regulation 4.4.2 (Once the Chequered Flag is displayed, Cars are not permitted to enter Pit Lane), the Stewards imposed the penalty of a 5 Minute Stop Go Penalty, to be served at the commencement of the Dunlop Super2 Series Qualifying for Round 1, on the following drivers:

- Car #62, Alex Rullo;
- Car #14, Macauley Jones; and
- Car #54, Nathan Morcombe

Following an investigation and an admission of a breach of Rule D3.1.2 (must not cross the Control Line more than once), the Stewards imposed the penalty of a 5 Minute Stop Go Penalty, to be served at the commencement of the Dunlop Super2 Series Qualifying for Round 1, on Car #23, Dean Fiore.
