Race Director Incident Determinations

Following a request for incident review from Garry Rogers Motorsport into an incident involving Car #5 Thomas Randle and Car #44 Chris Pither at Turn 7, the post-session RD investigation viewed the Judicial Camera footage of Cars #5 and #44 with no incident observed. Therefore, the RD has determined the incident did not warrant being referred to the Stewards.

Following a request for incident review from Brad Jones Racing into an incident involving Car #8 Zane Goddard and Car #38 William Brown at Turn 7, the post-session RD investigation viewed the Judicial Camera footage of Cars #8 and #38 and it was found Car #8 failed to leave sufficient racing room for Car #38. Therefore, the RD has determined the incident did not warrant being referred to the Stewards.
