Matters from Race 2:

Race Director Incident Determinations

There were no RD determinations.

Stewards' Decisions - Penalties imposed

The Stewards imposed a Post-Race Pit Lane Time Penalty of twenty five (25) seconds on Car #21, Jack Smith, for a breach of Schedule B2 Article 2.1.1 - Careless Driving. When attempting to overtake Car #18, Matt Chahda, at Turn 11 on Lap 20, the Driver of Car #21 locked brakes and collided with Car #18 causing Car #18 to spin and sustain damage as a result of which Car #18 was not classified.

Matters from Qualifying Race 1:

There were no RD determinations.

Stewards' Decisions - Penalties imposed

In accordance with Rule D6.1.11 the Stewards deleted the fastest lap time in the Session for Car #10, Brenton Grove, and prohibited him from taking any further part in the Session after Car #10 collided with the wall at the exit of Turn 8 causing a Red Flag.

Following the Session, the RD conducted an investigation into an allegation that the Driver of Car #35, Ash Walsh, failed to slow for Yellow Flags at Turn 8. After an admission to the breach, the Stewards imposed a 3 Grid Spot Penalty for Car #35 in Race 2.
