3. Commercial

- a. Current projections include a starting grid of 24 Supercars in 2022 however this number may change marginally depending on the total number of Racing Entitlement Contracts "RECs" issued prior to the commencement of the 2022 Supercars Championship. Additional supply requirements will be in accordance with demand. A minimum of two manufacturers are presently expected to be on the grid in 2022.
- b. The tenderer can opt to tender for the complete assembly of each or both manufacturers model or any element of it; however, tendering for the assembly of both manufacturers may be more attractive to Supercars. The tenderer may elect to tender to supply any one or more of the components and this will be considered by Supercars.
- c. Supercars will own all the tooling and associated IP linked to the tooling and parts produced.
- d. Attached with this tender is a pricing table excel workbook. You must complete and return the excel workbook by completing the pricing table for each component you wish to tender:

When completing the pricing table:

- i. Please list the products you wish to tender and a brief description.
- ii. Please include the tooling setup fee for each product; and whether there is an option to amortise the tooling fee across each product.
- iii. Please indicate the price per product:
 - 1. excluding tooling charges; and
 - 2. including an amortised tooling fee (if this option is available)
- iv. Please provide your pricing based on:
 - an MOQ of 36 for each component or if your MOQ is container volume dependent please specify the adequate MOQ for each component; and
 - 2. an MOQ for spare component orders.
- v. Please provide your pricing in AUD, CIF Brisbane, Australia including applicable taxes (excluding GST, import duties, and handling ex Brisbane).
- vi. Please specify your payment terms.
- vii. If you have any questions completing the pricing tables, please email Mark Adams madams@supercars.com
- e. The supplier must ensure that the availability of parts throughout the duration of the agreement will not directly impact Supercars' supply and/or cost.
- f. Prices quoted in year 1 remain fixed for the duration of the agreement.
- g. Prices must be quoted in AUD. The foreign exchange risk will remain with the supplier.

- h. The successful control bodywork supplier will contract directly with Supercars Australia and will be prohibited from entering into any arrangement or agreement with individual Supercars Teams.
- i. Components requirements:
 - Prototype components sufficient for two (2) Supercars, must be supplied to Supercars at its nominated address by no later than Monday, 3rd of May 2021.

4. Tender Document

It is expected that each tender document, will include the following:

- a. Complete bill of material, including component weights, laminate manual defining all components to support the function of the control bodywork.
- b. Approach of the engineering phase, if required, and detailed timing plan including the sign off testing.
- c. The warranty terms and conditions that will apply to the control bodywork detailing limits for all relevant parameters.
- d. As much as is possible, details of any projects the potential supplier/manufacturer has delivered or is delivering which relate to the technical or operational aspects of this projects. For each project, the role of the supplier/manufacturer should be detailed and with whom the contract exists or existed.
- e. Due to the confidential nature of the tender, any interested party is required to sign a non-disclosure agreement. The NDA can be obtained using the email contact details provided in Section 5.
- f. Upon completion of point e., a sample CAD of the bodywork can be obtained using the email contact details provided in Section 5.
