## 2024 SENTRY INSURANCE COMPANY NATIONAL TRUCK DRIVER APPRECIATION WEEK SWEEPSTAKES

## **OFFICIAL RULES**

## **PRIZES AND APPROXIMATE RETAIL VALUE ("ARV"):** For each daily
