

PROGRAM REQUIREMENTS

Cribl Specialized Partner

Partners must meet the program requirements defined in the table to the right to qualify for participation in the Partner Professional Services & MSSP specialization as a "Cribl Specialized" partner. In addition, you must have a current Cribl Partner Agreement and Cribl Professional Services Addendum or MSSP Addendum in place.

Cribl Certified Services Consultant (CCSC)

This comprehensive curriculum is targeted specifically for partner engineers who will take on hands-on Cribl architecturing and deployment responsibilities for customers. It builds upon the foundation of Cribl Certified User & Administrator training and certifications, and expands into knowledge and hands-on skill areas where a service consultant needs to master in order to drive successful implementations.

Implementation Success

Cribl defines a successful implementation as one where the customer is reaching the customer-approved desired daily ingest volume, and complete implementation of sources and destinations & routes and pipelines. Customers must indicate they approve the partner's implementation work by signing off on the Statement of Work completion. Cribl services team to provide ad-hoc and quarterly evaluation of partner implementation services work. Failure to correct implementation issues may result in termination from the Cribl program.

Maintaining Program Compliance

- Partner success is monitored quarterly as part of a Quarterly Business Review.
- Program eligibility is reviewed annually by Cribl Channel Program Management and Cribl Professional Services teams.
- Program membership will be automatically renewed for partners in good standing.
- Partner maintains eligibility by having no less than the required number of fully compliant PS consultants on staff, in accordance with the program requirements.
- Partners are "Cribl Specialized" to deliver standard Cribl implementations and managed services.
- Any other services provided cannot be performed under the Cribl specialization.
- Partner maintains eligibility by maintaining a high level of customer satisfaction on standard implementations, positive mentor feedback, and avoiding support escalations.
- Partner maintains eligibility by ensuring that implemented and/or managed customers have 90%+ product consumption on implemented products.
- Service territory is limited to the territory defined in the Cribl Partner Program Agreement.

How to Get Started

- 1. Contact your Cribl Partner Business Manager to express interest in the program
- 2. Cribl will evaluate partner's eligibility within one business week
- 3. If eligible, review and sign Cribl Partner Agreement and Professional Services or MSSP Addendum.
- 4. Identify partner consultants to complete the Cribl Professional Services Learning Path through Cribl University.
- 5. Obtain Certificate of Completion issued by Cribl for each individual that has successfully completed the requirements.

Cribl Certified User Certification

- Type: Online, self-study
- Prereqs: None



Cribl Certified Admin - Stream Certification

In-depth, practically-oriented courses to help prepare individuals to be the Stream expert within their organization.

- Level: 2
- Length: ~16–22 Hours
- Type: Online, self-study
- Prereqs: Cribl Certified User



Cribl Certified Services Consultant (CCSC)

This comprehensive curriculum is targeted specifically for partner engineers who will take on hands-on Cribl architecturing and deployment responsibilities for customers.

- Level: 3
- Length: ~17–21 Hours
- Type: ILC, Labs, Simulations
- Prereqs: Cribl Certified Admin Stream

Advanced Pipeline Packs

The Advanced Pipeline Pack will help assess the consultants ability to assist customers with real world data challenges. The Packs provide a set of self contained data samples of varied degrees of complexness and specific requirements on transformations. The consultant will complete these at their own pace and return the work to Cribl for feedback and completion tracking.

Simulated Delivery Assessment

Delivery Assessment involves a remote role playing exercise representing, as closely as possible, a real world Cribl deployment. Feedback will be provided to the consultant with success being met or clearly documented paths for improvement.
