HLT23221 Certificate II in Health Support Services is a VETiS program funded by the Queensland Government.

The VET investment budget provides funding for students to complete one Certificate I or II employment stream qualification listed on the [Priority Skills List](#) while at school.


- provide a Statement of Attainment for the units of competency successfully completed, and
