



U.S. Consumer Prices Rise 0.4% in February, as Expected [March 2021]

- Consumers are expecting higher inflation in the near-term, and more small businesses are planning to raise their prices. This comes after a surge in prices of raw materials and other goods that are put on the factories and service industries
- · Gasoline price increase accounted for over half the rise, but there is still very low demand for services like airline travel
- These inflated prices are expected to continue in the coming months as a result of price declines early on during the COVID-19 pandemic, but unsure how long this will last as the faster pace of the vaccine rollout allows the economy to reopen quickly
