MARKET COMMENTARY

- Significant M&A activity to close out 2019, with a number of M&A platforms continuing their consolidation plays;
- All sub-sectors' share prices grew healthily through Q4 2019, with the Local IT Services and Web Hosting sub-sectors outperforming their peers on average;
- According to Gartner, 2019's slowdown in IT spending is not expected to continue into 2020 despite concerns over a recession and companies reducing their discretionary IT spend;
- Growth in IT spending primarily driven by the rest of the world catching up on cloud (the U.S. currently accounts for over half of global spend);
- In today's complex geopolitical environment, regulatory compliance has become a priority for most organisations, with overall spending on security forecast to significantly increase over the next five years;
- Growth in Managed Services is expected to be driven by the growing dependence of enterprises on IT assets along with the need for specialised Managed Services Providers and cloud-based managed services; and
- As a result of global expansion, enterprises are either establishing new data center facilities or upgrading traditional infrastructure facilities to large-scale data centers integrated with modern technologies, enabling them to manage and protect the large amount of organisational data generated.
