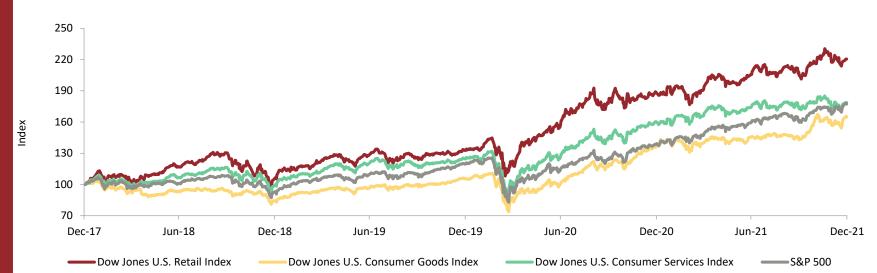

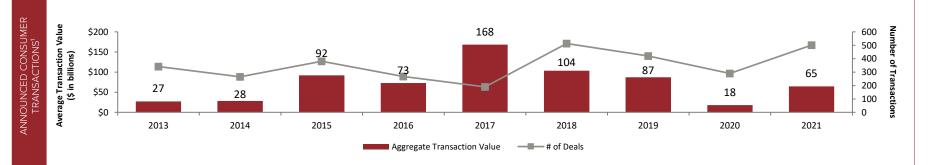

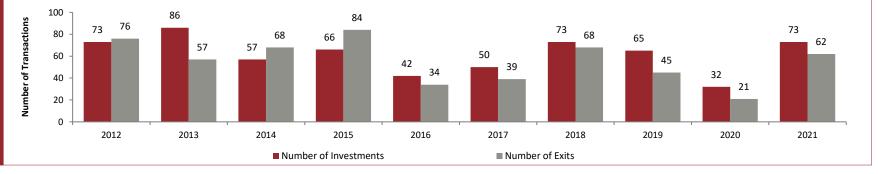

#### Store closures and reduced hours: here's how retailers are handling the Omicron surge [January 2022]

- Retailers and restaurants are facing the struggle of understaffing as the omicron variant compounds the existing worker shortage and threatens to exacerbate supply chain challenges
- Large big-box retailers like Macy's, Apple, and Walmart are among the retailers that have reduced hours or temporarily shut down locations with the latest COVID-19 wave
- Although there is a labor shortage, shoppers' appetite for spending remain high, though some are cutting back on visits to public places like restaurants, shopping malls, and coffee shops

#### Labor shortages weigh heavy on restaurant industry during holidays [December 2021]

- The holiday season is the busiest time of the year for retailers, and they have struggled with finding enough staff to support consumer demand
- According to the National Restaurant Association, 78% of restaurant owners across the U.S. report they don't have enough employees to support their current consumer demand
- In February 2020, the number of restaurant workers was over 650,000. Two months later, it crashed to a little more than 200,000

#### Holiday sales rise 8.5% despite supply-chain issues and Omicron variant [December 2021]

- Holiday sales rose 8.5% from the prior year, though shoppers struggled with product shortages and the new COVID-19 variant
- After Omicron hit, some consumers stayed home and shifted their spending online, but sales still surged
- For the week of December 18, store traffic was up nearly 20% from a year earlier, noting this is because shoppers are still going to brick-and-mortar stores but are now favoring open-air shopping centers and outlet malls
- Americans learned to adjust to product shortages, turning to alternatives if their top choices were not available through big-box retailers
