





Impact of COVID-19 on Cloud Managed Services and Hosting

The global COVID-19 pandemic represents a pivotal moment for Cloud Managed Services and Hosting as consumer, business and government behaviors change dramatically, with significant short- and long-term implications

Redcentric continues to experience strong demand with minimal impact from COVID-19, with share performance benefiting from the clarity and closure of the FCA investigation into historical accounting malpractices

HCL has outperformed the broader sector, displaying impressive deal win momentum in core IT service businesses resulting from strong cloud credentials and steadily building DX capabilities

etcompany continues to benefit from the strong performance the Danish IT services market, which comprises c.75% of its usiness, where growth in public and private segments is gnificantly outperforming the rest of Europe

Overall, the subsector continues to outperform the broader industry, with Shopify particularly benefiting from its exposure to small and medium-sized businesses who have had to rapidly shift online in the current environment

Equinix is benefiting from its expanding business moat as it continues to build scale and penetrate attractive and growing markets such as India

MANAGED SERVICES

Whilst COVID-19 has had a negative impact on many information and communication technologies, security services have witnessed increased engagements, especially in outsourcing services such as managed security services and managed detection and response. Security services is forecast to see continued strong demand in the medium term

IT SERVICES

The small and medium-sized IT segment is likely to see deeper IT spending reductions over the course of the next few years compared to large companies as the looming economic downturn will likely see a substantial number of small and medium-sized businesses ("SMB") close. Similar to the 2008 downturn, certain SMB IT spending that existed pre-crisis is likely to be lost and continue shrinking over the course of the next few years, albeit this will vary by region

WEB HOSTING

The web hosting subsector has greatly benefited from the impact of COVID-19 as it has driven small and medium-sized businesses online. Long-term consumer trends, such as the acceleration of eCommerce adoption, remain very positive; however, the near-term economic uncertainty is likely to impact its target market the most

DATA CENTERS / COLOCATION

The subsector had been benefiting from a structural shift in companies wanting to move their own business-critical applications from a controlled, on-premise data center to the cloud before the pandemic, a trend that has only accelerated in the current environment. Established data center providers stand to benefit in the near term; however they will face increasing competition in the medium and long term as large players known for installing hardware and appliances on-premise adapt to the changing environment


