APPLICATION RESOURCES

The Law Applicant Support Series (LASS) provides personalized, comprehensive support for all aspects of the application process:

- Law schools consider **undergraduate GPA** when evaluating your application and recognize that UChicago offers a rigorous curriculum. Because law schools don't prefer certain majors, you should pursue the major that interests you. Careers in Law advisers can share **detailed statistics** about law school admissions outcomes for individual law schools based on major, GPA, and other factors.
- Law schools typically require at least two academic **letters of recommendation**—from faculty who know you and your intellectual and analytical abilities. We can help you choose the best letters to show case your strengths and preparation.
- **LSAT**, the primary standardized test required by most law schools, is offered about ten times a year. You should begin LSAT prep at least three months in advance, using resources like free materials from [LSAC](#). UChicago also partners with Blueprint to provide [discounted access to Blueprint's LSAT prep courses](#). Schedule your [first LSAT exam attempt in February and your last attempt by October](#) so that your application will be complete by November.
- **Personal Statements** and **Supplemental Essays** are opportunities to share the motivations, values, and experiences that inform your decision to pursue law. We offer unlimited statement reviews to help you take advantage of this important part of the application.
- Your law school **resume** allows law schools the opportunity to see how you spend your time outside the classroom. Let us help you highlight the impact of your internships, leadership, service, and campus involvement.

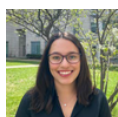
