	Application form duly completed and signed.
	One recent (less than six months old) <b>passport-size photograph</b> in colour with good resemblance (3.5cm / 4.5cm).
	<b>Current passport</b> should be valid for at least three months beyond the intended duration of stay in the Schengen area. The passport must have at least two blank pages to affix the visa. Copies of passport pages must be in colour.
	<b>Previous passports</b> (if any) + coloured copies of bio page(s) and previous Schengen visas and stamps.
	A cover letter from your organization/school/football club etc (printed on letterhead): <ul style="list-style-type: none"> <li>Name and date of birth of the applicant.</li> <li>An outline of the applicant's purpose of visit, how/why the trip is relevant to his/her current studies, and the period of intended stay in Denmark/Schengen.</li> </ul>
	A signed invitation letter from host organization/school containing/football club etc.; name of the invited applicant, purpose of visit, dates of the intended stay, nature of costs being covered by host (boarding & lodging).
	<b>Flight reservations</b> for round trip. If applicant is traveling to several Schengen states, proof of intra-Schengen flight reservation, train itinerary or car rental.
	<b>Proof of accommodation:</b> Hotel bookings or host guarantee/sponsorship of accommodation covering the whole duration of the intended stay.
	<b>Overseas travel medical insurance valid for all Schengen countries.</b> The insurance has to cover the applicant for the entire duration of the stay in the Schengen area and must cover for at least 30,000 EUR for all risks, e.g. accident, illness, medical emergency evacuation, etc
	<b>For Sports/Trials;</b> <ul style="list-style-type: none"> <li><b>Single Approval Letter issued by Identity Malta;</b></li> <li><b>Your employment contract;</b></li> <li><b>Three last pay slips or proof of last salaries;</b></li> <li><b>Letter of introduction from Ghana Sports Council and/or respective sports association/federation (FIFA registration in case of footballers).</b></li> </ul>
	In case of minors (< 18 years) traveling:

	<ul style="list-style-type: none"> <li>• If the minor is traveling with only one parent, written consent of the other parent or guardian, except in cases of a parent having sole custody or guardianship of the minor. Documentation of custody must also be provided.</li> <li>• If the minor travels alone (without parents), written consent (including contact details) from both parents or guardians having custody of the minor.</li> <li>• A photocopy of both parents' passports. If not, copies of the ID cards (with signature) of the parents.</li> <li>• Birth certificate for the minor</li> </ul> <p>Note: If minor traveling with one parent. All the above documents of the other parent required.</p>
	<p>Evidence of source of financial support/means of subsistence</p> <ul style="list-style-type: none"> <li>• Original personal bank statement showing movements in the last three months and duly stamped and signed by the bank.</li> </ul> <p>Please note that ALL applicants have to provide proof of pocket money in their own name even if their trip is fully sponsored</p> <ul style="list-style-type: none"> <li>• If applicant is employed: pay slips for the last three months, employment contract, bank statement for account through which salary is paid.</li> <li>• In case applicant is the proprietor/owner of the company: company registration documents, company's bank statement, tax clearance receipt, etc. are required</li> </ul>
	<p>In case the applicant's costs (flight ticket, accommodation) are covered by another person, a letter from the sponsor as well as copy of the sponsor's photo ID (e.g. passport card or driver's license), is required.</p>
